The Royal Government of Cambodia (RGC) through the Ministry of Land Management Urban Planning and Construction (MLMUPC) as Executive Agency and Ministry of Agriculture, Forestry and Fisheries (MAFF) as Implementing Agency have received financing from the World Bank for **Land Allocation for Social and Economic Development Project III (LASED III)** and intends to apply part of the proceeds to payments for goods, works and consulting services to be procured under this project.

5. The initial duration of the contract is two (2) years with possibility to extend depending on the need of the project. Probation period is 3 months, extendable based on satisfactory performance in the proceeding contract assessed by the project

The successful candidate will be selected in accordance with the Government Manual for Externally Financed Projects/Programs in Cambodia, issued in November 2019, e.g. Standard Operation Manual SOP, Procurement Manual (PM) and Financial Manual (FM) and the provisions of the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits (Version: Jan 2011 and revised Jul. 2014) and is open to all eligible individual consultants.
